## Conditions of Entry

1. If no registration form has been received, no pass will be granted and therefore no admission will be granted.
2. **One Pass Admits Two Persons Only**, any more than this will be charged a standard entry fee.
3. No plaques will be issued unless engines run for more than 50% of the duration of the show and exhibition vehicles are required to go around our ring at least once. Only one plaque per exhibitor will be issued after presenting a valid exhibitor pass and must be collected on show day as they will not be forwarded on afterwards. Exhibitors who arrive on the day unfortunately cannot be guaranteed a plaque as they are pre-ordered with our supplier. Plaques will be issued within the last hour of the show, and no sooner, unless otherwise agreed with the section leader.
4. Your exhibit will be insured under the minimum requirements of the Road Traffic Act, regardless of whether it is licensed for use on public highways. If your exhibit is not self-propelled, it will be covered by a Public Liability Policy and a Boiler Explosion Policy (for steam exhibits). Both policies provide an indemnity limit of at least £2,000,000 per accident, with Sparks and Ashes cover of no less than £100,000. You also confirm that the boiler of any steam-powered exhibit holds a valid Boiler Inspection Certificate and that you will provide documentary evidence of both insurance and inspection prior to participating in the event. Additionally, you declare that all drivers hold the appropriate class of driving licence and will present it upon request.
5. All exhibitors will be under the direction of the show stewards, specifically the section leader for their section during the show.
6. Read through the 'Guidance and Regulations for all Exhibitors' document that has been included, a copy can also be found on our website.
7. Please adhere to our showground rules which can be found on our website while exhibiting with us, to ensure the day is safe, fun, and enjoyable for everyone.
